I further authorize the National Executive Director, Marine Corps League to obtain an unredacted copy of my latest DD form 214 from the Marine Corps Custodian of Official Military Personnel Files (OMPF) or the National Archives, and/or verification of honorable service if deemed necessary to verify my eligibility for regular membership in the Marine Corps League. I understand the DD Form 214 may contain information such as military awards, training, and character of service.
